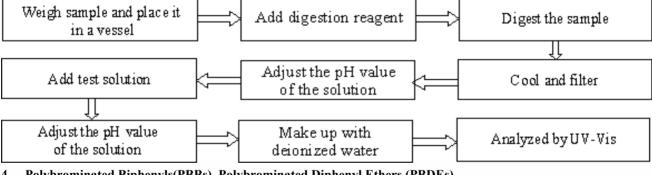

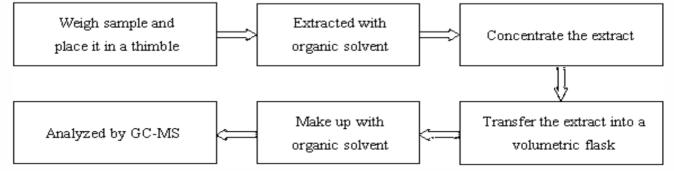
2. Mercury(Hg)



3. Hexavalent Chromium(Cr(VI))



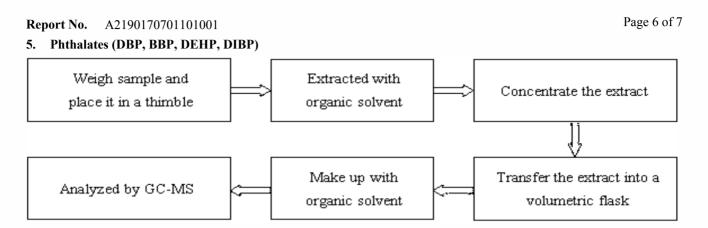
